Three neighbors curious about the neighborhood's newly-opened assisted living facility(ALF) banded together. We asked owner Jeff Reynolds to show us around and he immediately agreed to **President's Letter** do so. Our

trio learned that fire codes re-A Night with the quired Reynolds to spend about \$40,000 on the installation of sprinklers. "Even the closets are equipped with sprinklers!" Reynolds exclaimed.

> The facility is named Constant Care Assisted Living and is located at 11 Westmark. The house faces west onto the Westmark cul-desac and the back of the house looks east over Crestridge Avenue. There were three residents inhouse at the end of April and four at the beginning of June. Constant Care had two full time employees plus Mr. Reynolds at the time of our visit. They take care of the residents, maintain the property and prepare meals. Unlike other facilities, Constant Care

has no add-on charge for administration of medicines to residents.

Opening the front door, we were overwhelmed by a welcoming, airy ambience in the living room, the gas log fireplace blazing, a large-screen TV hung on the wall and seating provided by comfortable leather furniture. Carl noted that there were five sprinklers overhead in the living room. Located in the living room was a sign-in signout register. Beyond the living room was a goodsized dining room. The dining table was surrounded by sturdy wood chairs where residents enjoy their meals together and are invited to give input to daily menus. A counter separates the kitchen from the dining room. All outside walls have large picture windows which flood the upper level with natural light.

made their way through the new residence, we learned that there are five bedrooms, some of which can be shared. For instance, a large bedroom with private bath and shower on the front of the house costs \$4,000 per month. If two persons occupy the room, the cost would be \$2,500 per person per month. The shower has a seat and grab bars. Plans are afoot to insert a plug door in the tub

As our trio now descended to the lower level, we found that a door must be opened at the bottom of the stairs (safety reasons) and we walk down the usual number of steps to discover a spacious community room. It contains a large TV screen, leather seating and a miniature game and pool table.

Downstairs rooms go for \$2,388 to \$2,700 a month depending on how many persons occupy each bedroom. There is no elevator in the building but Reynolds plans facility. The doors are to install a railing lift chair.

The first Constant Care resident is Karen. She occupies herself by working on the lawns, gardens and raising flowers under the supervision of an employee. Rosycheeked Karen is very pleased to have her own room, bath, a few pieces of her furniture and pictures of her late husband on the dresser.

The Constant Care brochure Edna remarked that "The claims " We are an assisted living facility...that serves retirees that don't want the crowds and long hallways of most assisted living facilities." We three Stratmoorites believe that they've reached their goal. This place is more like an upscale modprepared meals, big winis like a "facility." We'll see how things sort out when the total of eight occupants is reached, which

now afforded with only four occupants. There are no long hallways and there's enough space at this time for those who don't want to live hip-tohip.

Reynolds will accept M edicaid clients which many ALFs do not. Medicaid will help pay for assisted living. He is awaiting his Medicaid license which is on the way. He is currently investigating the Veterans Administration "Aid and Attendance" program which will pay benefits on a sliding scale for veterans (and their spouses) who served in any capacity during war and conflicts.

"I am determined to maintain the Westmark property in good condition so it will continue be an asset to the neighborhood," said Reynolds. He is planning another Constant Care ALF for the north side of Colorado Springs.



Jackie and Joe Schimpf By Shelia Egan

Joe Schimpf murmured "Burn Baby Burn!" as he watched his Widefield house burn down in 1993. The fire was started by a neighbor's fireworks. But the destruction of Joe and Jackie's home was good news for the Stratmoor Hills Neighborhood Association when the Schimpfs built a new house on Loomis Avenue. Jackie is our diligent and inspired Hostess who has initiated raffles at our meetings. Joe was appointed "Enforcer" which means he is good at collecting money at Clean Up Day and generally keeping order. Both Schimpfs are members of the Board of Directors for our Associa-Jackie was born tion. and raised in a little west Texas town called Muleshoe. When Jackie was 12, her family moved to Dallas and later she worked in Wichita Falls. She attended a USO party at Shepard Air Force Base in Wichita and met a young Airman, Joe Schimpf. They married in 1960 and became parents to sons in 1961, 1962, 1963 and a bonus boy in 1970 when Joe returned from Viet Nam. The sons now live in Flor-

ida, Canon City, Guffey and Colorado Springs. When Joe was ordered to Vietnam, Jackie took her sons to live in Muleshoe. During her time, there **Jackie learned about** prejudice which she emphatically does not tolerate. She was placed in the position of confronting a school teacher who was unkind to her son. The teacher compared the life of an Air Force family to that of an immigrant family.

Joe, of German ancestry, was born in Marienfeld, Ukraine. German families lived peacefully and thrived in Ukraine until WW II broke out when the Russian government expelled all Germans. The Schimpfs went to Poland to stay with a German family. They moved on for nine months to Northern Germany and were referred to as "Ruskies." Joe was just a young boy but worked shoulder to shoulder with his father and other men on a farm, which provided food for the families as the war raged on.

In 1952, the family (consisting of Joe's par-

ents, two sisters and two brothers) departed for the USA, went through Ellis Island, and then to Virginia and North Carolina. Joe had commenced his education in public schools. In 1958 he enlisted in the United State Air Force where he became a Power Plant Technician. The Air Force wanted Joe to see the world, so they stationed him in Turkey, Berlin, California, Viet Nam, Alaska and at NORAD where his retirement ceremony was held after 25 years serving his adopted country. Jackie and Joe with their four sons spent four years in Berlin, which was a complete delight for Jackie and the shopkeepers as she spent all her deutschmarks.



Mr and Mrs Schimpf moved to Stratmoor Hills after the loss of their Widefield home in 1993.

Jackie enjoys machine embroidery, baking, cooking and participating in spoiling her grandchildren. She speaks fluent German and is especially known for Hostessing at our SHNA meetings, providing a welcoming smile, a warm handshake, hot tea or coffee and offering tickets to buy for the raffles Jackie has initiated and which have puffed up our treasury very nicely. Joe's hobbies were fishing and hunting until his physical condition ruled out these sports. He can still be a "shade tree mechanic" however. The Schimpfs belong to St Joseph Catholic Church.

Earth Movers & Rain Catchers A Night with Dennis Hisey

Commissioner Dennis Hisey spoke to a crowd of over 50 people on April 2, 2014 at Stratmoor Hills Elementary where he addressed a new shopping center and other issues which affect Stratmoor residents. Perhaps you have seen the large trucks and heard their thunder? It can be no wonder when 300 million cubic yards of dirt are being moved south of B street and north of Pikes Peak Community College County. The site will host a new Walmart Supercenter and Sam's Club with a projected opening in October 2015. Dirt useful for building is placed on the top and as unusable dirt will be packed underneath. An experienced, nation-wide developer is currently working on preparing the project which it will then pass on to a builder. Building will begin at the north end of the site and access will be at Academy only for the initial stores. There will be other pad sites to follow after Sams and Walmart open and dates for these will depend on how the first phase goes. Eventually, there will be access from B Street and Venettucci as well.

The second order of business was the veterans cemetery to be built south and east of the airport. Three hundred seventy four acres have been approved for homes but will be used for the cemetery instead. The VA plans to advertise and award architect contract by summer master plan 6-7month process. A Master plan should be in place by year end. The tentative completion date is 2-3 years and there is money in place and set aside for it. Many interments per day are expected and a large traffic increase is anticipated.

Third, Storm water management must be addressed and we may all be affected. Though we do not generally live in a flood plain, there have been residents nearby who received FEMA assistance. There is a citizen's task force recommending :

I.a regional storm water authority 2.a vote to approve regional storm water authority 3 fee collected based on impervious surface such as a roof or a drive way much like a fee (not a tax) for a drivers license 4 a group of elected officials to pass models through limited to administration fees 1% to prevent this from becoming a "new government" branch. The fee would depend on size of lot and mitigation of storm water through natural landscaping. This would come on the property tax bill. A guess as to the amount involved \$ 8-\$12/month or approximately, \$100/year for the average household. Colorado state law does not allow for collecting storm water in barrels the best thing is for the rain to go into the ground. Colorado soil, being made of clay is considered "hydrophobic" or not good at absorbing water which may cause this type of flooding for many years to come. The fountain creek water shed inc. is overseer over two hours adfor Colorado Springs and Woodland Park through the county line south of Fort Carson which comes to a point in Pueblo. An Engineer hired to review projects and make recommendations for effectively managing storm waters in the region estimate costs at somewhere in the \$ 600 million to \$800 million range; not accounting for the Waldo Canon burn scar. If the option is placed on the ballot, it would likely be under closer to \$30 million dollars. The population in the

area is reaching 650 million. Thank you Commissioner Hisey for a your time and insight!

. WHY WAS CLEAN UP DAY HELD ON A FRIDAY?

Several inquiries were voiced as to why our annual May Clean Up Day was held on a Friday this year. Here's the answer: We learned that if we held the event on a Saturday, we would have to pay the County HazMat team \$100 per hour. Paying that much for weekend help was not feasible and paying them was a recent decision by the County Commissioners. Haz-Mat pay would be far more than the cash donations we would receive.

Because school was open on Clean Up Day, we shifted our site to property owned by the Stratmoor Hills Volunteer Fire Department at B Street and Crestridge where we had more room to maneuver the dumpster, direct cars dropping canned goods or trash. The good news is that we were able to rent a dumpster through the aus-

pices of El Paso County, the cost of which was less than we've paid for a dumpster in the past.

The Event is held as a service to our good neighbors who completely filled the dumpster and the HazMat truck between 7am and 10am, who generously donated 76 pounds of canned goods and who handed over \$236.61 in cash. The canned goods were given to the Food Pantry on B Street behind the 7-11 at B Street and Crestridge.




